**MEMORANDUM OF UNDERSTANDING**

Between

**EMBASSY OF ISLAMIC REPUBLIC OF IRAN**

**AND**

**RADEN FATAH STATE ISLAMIC UNIVERSITY**

**PALEMBANG INDONESIA**

This Memorandum of Understanding is made on 01 March 2019

between

Embassy of Republic of Iran (EIRI) located in 110, Jl. HOS Cokroaminoto, Menteng, Jakarta, 10310

And

Raden Fatah State Islamic University Palembang Located in Jl. K.H. Zainal Abidin Fikry Km. 3,5  
Palembang, 30126

The parties, after due consideration of various aspects, have arrived at the following understanding in respect of the inauguration of Iran Corner in Raden Fatah State Islamic University Palembang, by the conditions and requirements as follow :

## **Paragraph 1**

### **Scope and fields of Academic link and Cooperation**

Each participants will, subject to the laws, rules and regulation as well as national policies of the both sides from time to time in force, governing the subject matter in their respective countries, endeavor to take necessary steps to encourage and promote cooperation in the following fields.

#### **1.1 Inauguration of Iran Corner**

Both sides have agreed to inaugurate a corner called “ Iran Corner ” in the Raden Fatah State Islamic University Palembang in order to exchange the scientific as well as cultural relations between Embassy of Islamic Republic of Iran and Raden Fatah State Islamic University Palembang on the side of Indonesia.

#### **1.2 Scope of Activity**

- I. The participants may jointly decide to explore possibilities of developing joint or collaborative research in the field of mutual interest. Such collaboration may include seminars leading to publications, field work for joint research projects, short courses, placing Persian Language as an obligatory subject in the Arabic studies and scholarship in Master's and Doctoral Degree Program
- II. This field of Iran Corner may include activities in all Faculties at Raden Fatah State Islamic University Palembang as well as Universities, colleges, and scientific center in Palembang.
- III. The plans and programs of Iran Corner shall be publicly announced subsequent to consultation of authority of Embassy of Islamic Republic of Iran, namely the cultural Counselor, with Iran Corner Authority which shall be pronounced to the University which is taken as University accountability.

#### **1.3 Exchange**

##### **I. Exchange of Students**

Exchange of Students, both undergraduate and graduate may take place for the purpose of visit, study research for such duration to be mutually decided. Students may be

accepted to undertake research on such terms and the conditions to be agreed upon mutually in writing between the participant.

II. Exchange of Faculty Members

Exchange of Faculty Members between the two participant may take place for purposes that will be mutually beneficial to both participants. Such purposes may include study visit, discussion, research, teaching, training, and other related grounds. Exchange of the Faculty Members may be extended to administrative, library and non-teaching staff in various areas for the purpose of visit, work attachements or training courses.

III. Exchange of Publication

The participants may exchange academic, scientific, historical, and research publications and literature in area of approved mutual collaboration. Exchange of Publications may include the exchange of audio-visual materials and other items for teaching and research.

## **Paragraph 2**

### **Obligation and Financial Arrangement**

2.1 Responsibility of the Embassy of Islamic Republic of Iran (EIRI)

- I. EIRI provides information regarding selected reference books, CDs, DVDs, software, and subscribe e-journal which emphasize on all cultural, religious, societal, and political aspects, As well, EIRI shall provide attributes of Iran, poster, banners, and maps to Iran Corner.
- II. EIRI provides a set of computer, a TV and a printer which will be used to access and manage information sources of Iran and those equipment will periodically update or replace provide that those aforementioned equipment cannot be repaired.
- III. EIRI facilitates and partakes various programs of seminar, academic and cultural discussion, exhibition about Iran based on mutual agreement
- IV. EIRI will conduct routine coordination activity with the director of Iran Corner.

2.2 Responsibility of Raden Fatah State Islamic University Palembang

- I. Raden Fatah State Islamic University Palembang should provide adequate room to support the activity of Iran Corner which mutually agreed by both participant. The room which will be provided should accommodate all books and equipment which will be given by EIRI.

- II. Raden Fatah State Islamic University Palembang appoints a full time director for Iran Corner in communication with the EIRI for a year which the salary is undertaken all by the Raden Fatah State Islamic University Palembang. The extension of the term is permissible provide that both participant agreed upon.
- III. Raden Fatah State Islamic University Palembang take care and maintenance all facilities, equipment and device of Iran Corner in order to be utilized as it should be. As well, the cleanliness of the room should be preserved by Raden Fatah State Islamic University Palembang .
- IV. Raden Fatah State Islamic University Palembang provide internet connection to support the internet access at Iran Corner and a telephone line to support the communication.
- V. Raden Fatah State Islamic University Palembang provide bookshelf, desk and chairs for visitor and a working table and chair for the director of Iran Corner.
- VI. Raden Fatah State Islamic University Palembang provide room for the activities of Seminar, discussion, exhibition, and Persian Language Course.
- VII. Raden Fatah State Islamic University Palembang provide accommodation, reception and welcoming committee for the Iranian and Non-Iranian delegation in the events which are mutually agreed upon.

### **Paragraph 3**

#### **Commencement, Duration, Termination**

- 3.1 This MOU will commence on the date of signing by the participants or their authorized representative, namely the Cultural Conselor on behalf of EIRI, and will remain to be effective for four (4) years from the commencement date.
- 3.2 After this initial four (4)-years span, this MOU is permissible to be extended for a future span of four (4) years unless both participants mutually decide in writing to its termination.
- 3.3 Subject to the foregoing provisions, this MOU may be terminated at any time by either participants, subject to giving at least six (6) month prior to termination. Written notice of such termination to the other participant is obligatory.

### **Paragraph 4**

#### **Endowment**

Subject to any foregoing provision, all books, facilities and what so ever which is belong to Iran Corner is endowed to the library of Raden Fatah State Islamic University Palembang.

## **Paragraph 5**

### **Effect of MOU**

This MOU does not constitute or create and will not be deemed to constitute any legally binding or enforceable obligation on the part of either participant unless and until an agreement regarding each objective is negotiated, executed and delivered by the participants.

## **Paragraph 6**

The legal representative of Embassy of Islamic Republic of Iran in Jakarta here in is Cultural Consellorship of Embassy of Islamic Republic of Iran and all obligations and accountabilities of Iran Corner is shouldered by this section.
