a) Methods of payment:


The Partner will receive an advance payment of IDR 55.000.000,-. The final payment will be made after the finalization of the measure/event and after submission of all financial and qualitative documentation as requested in this agreement.

The Cooperation Partner guarantees that it will not have the costs here agreed financed by other sources, and provides information about additional partners in the measure. The funds assured under this Agreement relate exclusively to the agreed measure and cannot be transferred to other measures without prior approval.

- b) Presentation of accounts (expenses): All expenditures must be recorded in the submitted excel file (Annex 2). All original receipts and additional documentation must be submitted within 2 weeks after finalization of the event, according to the local accounting rules.
- c) Presentation of results: A final executive summary must be submitted to KAS after finalization of the event, together with the financial report of the event.

Final Provisions

- a) that must reasonably be considered confidential without the respective other Party's approval.
- b) The law of the Republic of Indonesia is applicable to this Agreement. Disputes arising in connection with the Agreement should, if possible, be settled by mutual agreement. In the case of doubt, KAS reserves the right to take legal steps.
- c) There are no ancillary agreements to this Agreement.
- d) Amendments and supplements to this Agreement must be in the written form. This also applies to waiving the written form requirement.
- e) By signing this Cooperation Agreement, both Contracting Parties commit themselves to a transparent and fair cooperation.
- f) The following language versions of this contract are valid: English; the contract is signed in duplicate.
- g) Should individual provisions of this Agreement be invalid or unenforceable, the Parties undertake to replace the invalid or unenforceable provision with a new provision immediately which in its effect comes as close to the invalid or unenforceable provision as possible.
